NEAT CIOS – Item Check In/Out System



Use **NEAT CIOS – Check In/Out System** to:

- Display items are in the stockroom or removed
- Indicate who removed items and when
- Alarms via Email and display if an item was removed without being checkout through the system
- Schedule required inspections of items and keep detailed records of all inspections
- Search of items by name, manufacturer or other fields
- View historic reports based on item, personnel or location include item was checked out
- Save time and resources by knowing the status of all inventory items

NControl is pleased to offer a new concept in RFID tracking systems, **NEAT CIOS**. The system is designed to monitor and control stockroom items with an easy to use application. The system uses RFID readers at access points to the stockroom to monitor for items. If an item is 'seen' at the stockroom exit point, the system will display the item on the workstation, allowing users to check in or out the item via credential or manual input.

The **NEAT CIOS** system consists of two different applications that run in tandem to complete the system. They are the **NEAT CIOS Workstation** application, which collects and stores the information from the RFID hardware and allows items to be checked in or out and the **NEAT CIOS Reporting** application.

Item location information can be accessed using this web-based user interface. Users can instantly view current stockroom inventory, items checked out, items requiring inspection and other historical reports by item, person removing items, or reader location.

NEAT CIOS is designed to monitor multiple stockroom access points and update item location regardless of which doorway items are moved through.

Like all other **NEAT** systems, item description information can be entered into the system. As items are seen, the entered information will be displayed. Photos and files can also be displayed. Items can be search by field defined and used in the system.

NEAT CIOS includes an inspection reporting option. When items are entered into the system, the user can define a date when the item requires inspection. As the inspection date nears, the system will notify the user of the required inspection. Once complete, user can complete the inspection report and add a new inspection date. **NEAT CIOS** include a report of all item inspections.

For extra security, **NEAT CIOS** is designed to notify personnel, via EMAIL alarm, if an item was seen at a stockroom exit point, but was not checked in or out through the system. The workstation application will also indicate give the same alarm.
